The contribution of our 2023 projects to the SDGs

In 2023, 94 new authorised projects, worth €2.3 billion,¹ will actively contribute to achieving the Sustainable Development Goals (SDGs).²

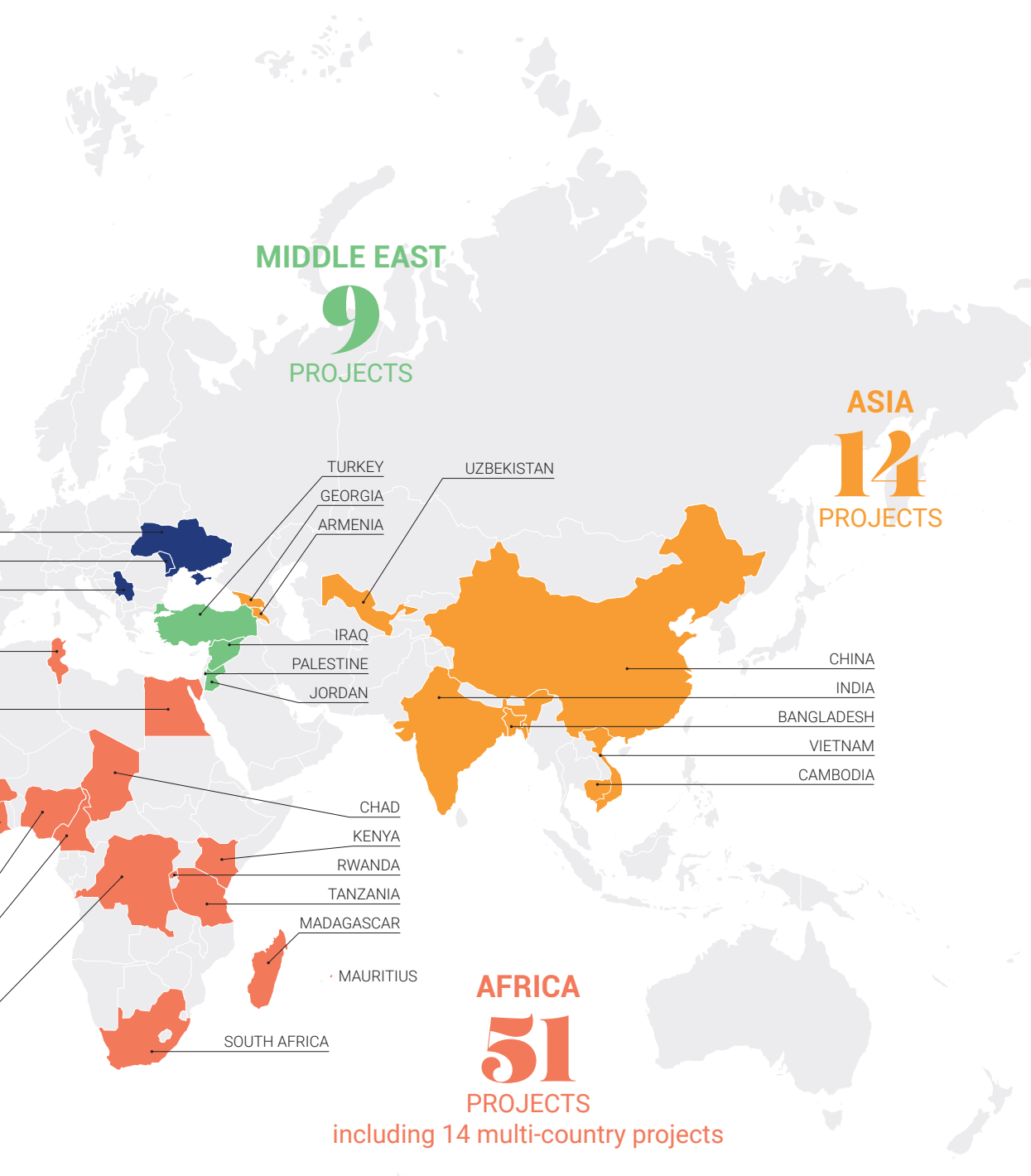

Monitoring our impacts 2017-2021

The 2023 impact monitoring exercise **involved 312 projects signed between 2017 and 2021, for a total amount of €5.5 billion**. This covers a total of **265** customers.

The annual monitoring exercise enables *ex ante* impact estimates to be compared with impacts observed during project implementation.

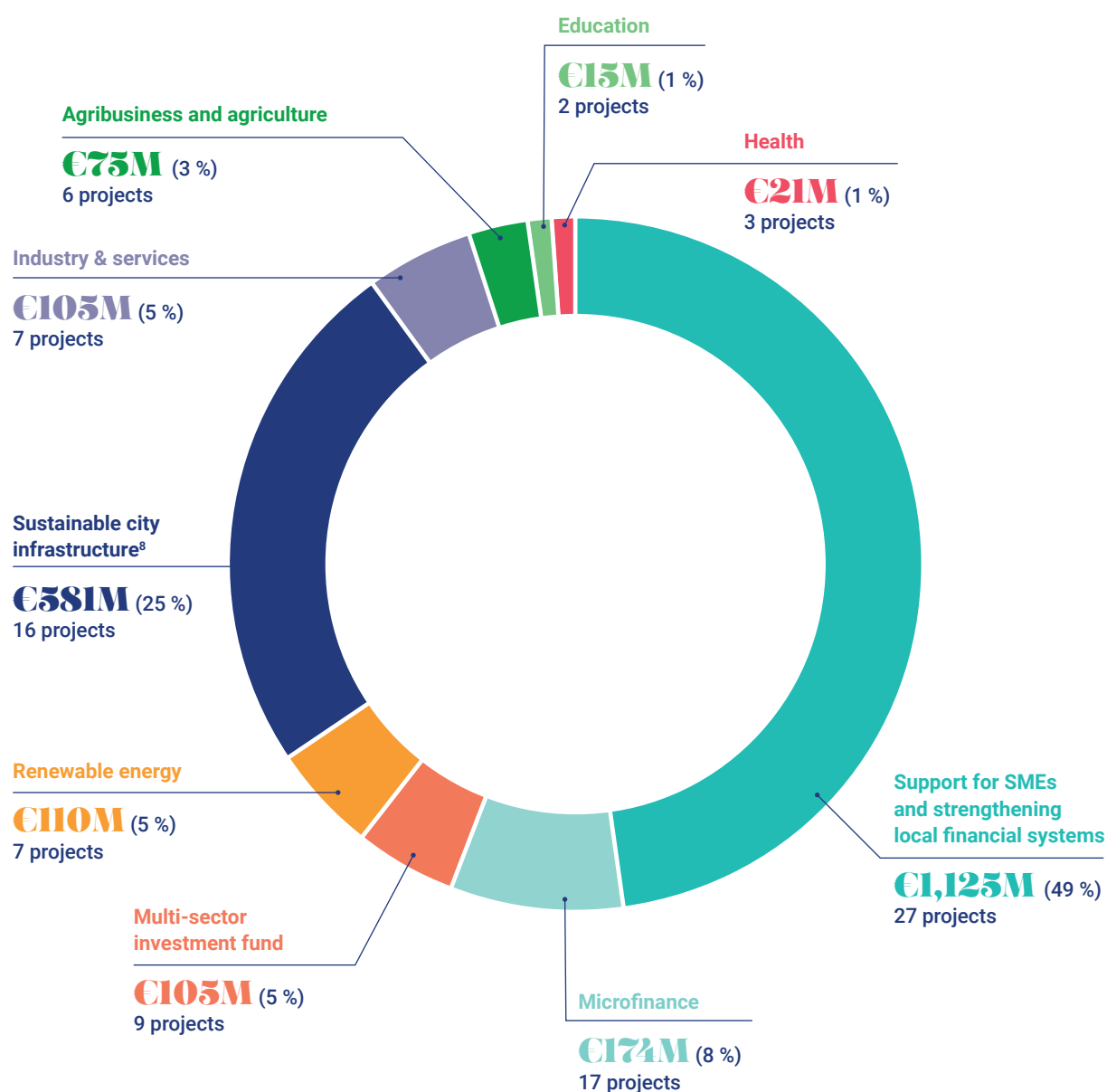
